





To address emerging challenges in public health education and research, it was upgraded to the School of Public Health (SPH) in the Tenth Five Year Plan of India (2002-06). Department of Community Medicine & School of Public Health conduct post-graduate teaching programmes and short-term training courses on various public health issues, conducts research projects in collaboration with national and & sub-national organizations and governments and also provide consultancy services to state and central health services on various public health matters. The department has developed various public health models which have been successfully scaled and replicated across the country.

Our Commitment towards Tobacco Control

Department of Community Medicine & School of Public Health has been actively leading tobacco control efforts from over a decade. It has published a dedicated module for public health students on tobacco control. The school is also supporting National Tobacco Control Programme (NTCP) in various states of the country in close collaboration with medical colleges and state health services. The Department is also hosting a virtual Resource Centre for Tobacco Control (www.rctcpgi.org) for increasing access to reliable and accurate information on tobacco control to policy makers, implementers, academicians and civil society.
